Mortgage Recording Tax Rates In New York City

Mortgages *less than* \$500,000 **2%**

Regardless of how property is improved;
(Borrower pays 1.75%, Lender pays .25%)†

Mortgages of \$500,000 *or more* on 1, 2, or 3 family **2.125%**

dwelling or individual residential condominium;
(Borrower pays 1.875%, Lender pays .25%)†

Mortgages of \$500,000 *or more* on property other **2.75%**

than 1, 2, or 3 family dwelling or individual residential condominium;
(Borrower pays full 2.50%, Lender pays .25%)†

Notes:

† In New York State where the premises is improved, or to be improved, only by a single structure containing not more than six residential units, the lender is required to pay a portion of the total mortgage tax due at the rate of .25% of the mortgage amount. Premises improved only with a 1 or 2 family dwelling, and the mortgage recites same, a \$25 reduction is applied to the borrower's portion of mortgage tax. All other property types require the borrower to pay the full tax rate.

If the lender is a natural person, or an exempt entity such as a federal credit union, the lender is exempt from paying .25% of the mortgage tax under Tax Law Section 253.1-a(a). A Section 253 Affidavit must be recorded to claim the exemption. A sample form can be found in the Forms Link on our website.

Mortgages for \$10,000 or less made on premises improved only with a 1 or 2 family dwelling, receive a mortgage tax rate reduction of .25% in favor of the borrower, although the \$25 deduction is removed.

New York City Only: Mortgages made on the same premises within a 12 month period of each other are aggregated for mortgage tax computation. If the aggregated amount exceeds \$500,000 you must pay the higher mortgage tax rate on the new indebtedness and on the difference between the higher mortgage tax rate and the actual mortgage tax rate previously paid on the old indebtedness.

Situations involving mortgages covering premises in more than one county, negative amortization or government financing may require special attention and will be handled on a case by case basis.
